






**AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MARMADUKE, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MARMADUKE, ARKANSAS, AND ASSIGNING SAME TO WARDS.**

WHEREAS, a petition was filed with the County Clerk of Greene County, Arkansas, by David Bruce Drope and Sara M. Drope, his wife, the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Marmaduke, Arkansas, and

WHEREAS, the 31<sup>st</sup> day of May, 2002, the County Court of Greene County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Marmaduke, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner described by law, and that all things pertaining thereto have been done in the manner described by law, and that lands and territory should be annexed to and made a part of the City of Marmaduke, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARMADUKE, ARKANSAS, AS FOLLOWS:**

**SECTION 1:** That the following described lands and territory contiguous and adjoining the City of Marmaduke, Arkansas, be and the same is hereby accepted as part of and annexed to and made a party of the City of Marmaduke, Arkansas:

That part of the Northwest Quarter of the Northeast Quarter of Section 13, Township 18 North, Range 6 East, described as follows: Beginning at the Northwest corner of said tract; run thence South 940.0 feet to the true point of beginning; thence continue South 258.0 feet; run thence East 216.2 feet; run thence North 75 degrees 17 minutes East 103.4 feet; run thence North 00 degrees 05 minutes West 231.7 feet; run thence West 315.8 feet to the true point of beginning, containing 1.84 acres, more or less. Subject to Greene County Road No. 438 along the West side thereof.

**SECTION 2:** That the above described territory shall be annexed and made a part of Ward III of the City of Marmaduke, Arkansas, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

**WHEREAS**, the 20<sup>th</sup> day of March, 2003, the County Court of Greene County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Marmaduke, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner described by law, and that all things pertaining thereto have been done in the manner described by law, and that lands and territory should be annexed to and made a part of the City of Marmaduke, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

That part of the Northwest Quarter of the Northeast Quarter of Section 13, Township 18 North, Range 8 East, described as follows: Beginning at the Northwest corner of said tract; run thence South, 780.0 feet to the true point of beginning; run thence East, 315.6 feet; run thence South 00 Degrees 05 minutes East, 160.0 feet; run thence West 315.6 feet; run thence North, 160.0 feet to the true point of beginning, containing 1.15 acres more or less. Subject to Greene County Road #438 along the West side thereof.

**SECTION 2:** That the above described territory shall be annexed and made a part of Ward III of the City of Marmaduke, Arkansas, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

WHEREAS, on March 22, 2016, the County Court of Greene County, Arkansas, found that the petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Marmaduke, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Marmaduke, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by the County Court has expired and no appeal has been taken from said order. Now, therefore, be it ordained by the city council of the City of Marmaduke, Arkansas:

Section 1. That the following described lands and territory contiguous and adjoining the City of Marmaduke, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Marmaduke, Arkansas:

A part of 36 acres of land in the Southeast corner of South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East, more particularly described as beginning at the center of said Section 13, and running thence North with the Quarter Section line 13 ½ chains to a stake; thence West 26 2/3 chains to a stake, thence South 13 ½ chains to a stake in the East and West Quarter Section line, thence East with said Quarter Section line 26 2/3 chains to the place of beginning, that part herein conveyed being described as follows: Beginning at a point of 550 feet East of the Southwest corner of said above described tract as a point of beginning, and running thence North 13 ½ chains to the North boundary line of said tract, thence East along said North line a distance of 250 feet; thence South 13 ½ chains to the South line of said tract; thence West along and with the South line a distance of 250 feet to the true point of beginning

That part of the South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East described as follows: Beginning at the Southeast corner of said tract, run thence North 89 degrees 08 minutes West 527 feet to the true point of beginning, run thence North 89 degrees 08 minutes West 213 feet, run thence North 600 feet, run thence South 89 degrees 08 minutes East

213 feet, run thence South 600 feet to the true point of beginning, containing 3.0 acres, more or less

That part of the South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East, more particularly described as follows: Beginning at the Southeast corner of said tract, run thence North 0 degrees 01 minutes East 908.7 feet, run thence North 89 degrees 36 minutes West 528.0 feet to the true point of beginning, run thence North 89 degrees 36 minutes West 432.0 feet, run thence South 304.0 feet, run thence East 432.0 feet, run thence North 301.0 feet to the true point of beginning, containing 3.0 acres, more or less, AND subject to any utility easements and any additional easements or rights-of-way associated with the television tower lease agreement of those lands lying South of the above described tract.

Also a 25-foot access easement, the centerline of which is described as follows: That part of the South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East, more particularly described as follows: Beginning at the Southeast corner of said tract, run thence North 0 degrees 01 minutes East 854.6 feet to a point on the centerline of a proposed 25 foot drive for the true point of beginning, run thence North 89 degrees 36 minutes West along said centerline 527.9 feet to the East line of the above described tract.

That part of the South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East, described as follows: Beginning at the Southeast corner of said tract, run thence North 89 degrees 08 minutes West 197 feet, to the true point of beginning, run thence North 89 degrees 08 minutes West 330 feet, run thence North 220 feet, run thence South 89 degrees 08 minutes East 330 feet, run thence South 220 feet to the true point of beginning, containing 1.68 acres, more or less

That part of the South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East, described as follows: Beginning at the Southeast corner of said tract, run thence North 89 degrees 08 minutes West 197 feet, run thence North 220 feet, run thence North 89 degrees 08 minutes West 330 feet, run thence North 681 feet, run thence South 89 degrees 36 minutes East 528.0 feet, run thence South 908.7 feet to the true point of beginning, subject to any utility easements, and any easements for access between the other tracts located adjacent to said tract.

That part of the South Half of the Northwest Quarter of Section 13, Township 18 North, Range 6 East described as follows: Beginning at the Southeast corner of said tract, run thence North 89° 08' West 740.9 feet to the true point of beginning, run thence North 89° 08' West 219.0 feet, run thence North 596.8 feet, run thence East 219.0 feet, run thence South 600.1 feet to the true point of beginning, containing 3.0 acres, more or less.

The part of the Northwest Quarter of the Northeast Quarter of Section 13, Township 18 North, Range 6 East, described as follows, to-wit: Beginning at a point on the West Line of said tract 580 feet South of the Northwest corner of said tract, run thence East 112 feet, run thence South 200 feet, run thence West 112 feet, run thence North 200 feet to the point of beginning, containing .51 acres of land, more or less, and subject to all existing road rights of way and utility easements.

SECTION 2. That the above described territory shall be annexed to and made a part of Ward III of the City of Marmaduke, Arkansas and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

SECTION 3. That the services listed in the schedule of services contained in the petition shall be extended to the annexed area within three [3] years after the date the annexation becomes final. The scheduled services contained in the petition are:

1. Water/Sewer
2. Police
3. Fire

The schedule of services shall be included in the annual written report required by ACA 14-40-2201 and 14-40-2202.
