





Arkansas Code 14-40-101.

DECREE OF ANNEXATION

On this regular day of a regular term of the County Court of Clark County, Arkansas, there is presented to the Court by John Houston Fowler and William Halbrook, sole owners of the property being requested for annexation, a petition for annexation of certain territory, hereinafter more particularly described, to the City of Caddo Valley, Arkansas, and the Court being fully advised of the facts and the law, doth hereby find, judge and decree as follows:

The Court finds that the petition was filed more than thirty (30) days prior to this date and that in said petition the said John Houston Fowler and William Halbrook being the sole owners of the property proposed for annexation represent the majority of the total number of real estate owners in the area affected; thus, both parties were acting on their own behalf in filing and presenting said petition.

The Court further finds that attached to and made a part of said petition is an accurate description and accurate map of the territory sought to be annexed and that said territory is contiguous to the boundaries of the City of Caddo Valley, Arkansas.

The Court further finds that a hearing date was set and held on March 16, 2007 and that between the time of filing of the petition and the date of said hearing, the petitioners caused a notice to be published once per week for three consecutive weeks


The Court further finds that the request of the petition is right and proper.

Therefore, the Court doth hereby ORDER, JUDGE and DECREE that the following described territory be and the same is hereby annexed to and made a part of the City of Caddo Valley, Arkansas to wit:

A parcel of land being located in the SE/4 NE/4 and the SW/4 NE/4 Section 21 Township 6 South Range 19 West, Clark County, Arkansas, and being more particularly described as follows: beginning at the northwest corner of the SW/4 NE/4 Section 21 Township 6 South Range 19 West, thence east along the north line of the SE/4 NE/4 and the SW/4 NE/4 1,554.67 feet to the north right of way line of U.S. Highway #67, thence southwesterly along the north right of way line of U.S. Highway #67 1,840.17 feet + or - to the west line of the SW/4 NE/4, Section 21 Township 6 South Range 19 West, thence north 699.14 feet back to the point of beginning. Being land further described in a survey dated June 6, 2006 by Lamar Kelly, R.L.S. #1014, and recorded in the records of Clark County, Arkansas, Plat Book 2, Page 294.
