




Arkansas Code 14-40-101.

RESOLUTION NO. 2014-06

A RESOLUTION TO ACCEPT CERTAIN LAND KNOWN AS THE PISTOLE LAND INTO THE LIMITS OF CITY OF CLINTON, ARKANSAS

WHEREAS, THE CITY COUNCIL OF CLINTON, ARKANSAS is aware that The County Court of Van Buren County, Arkansas has heard and granted the Petition of Jeff Pistole and Donna Pistole to have certain land annexed to the City of Clinton and found that all the legal prerequisites for same were established;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CLINTON, ARKANSAS, THAT:

Section 1. THE CITY OF CLINTON, ARKANSAS resolves to accept said territory into its limits, such land being in particular.

THE EAST ONE HALF, EAST ONE HALF (E ½ E ½), SOUTHWEST QUARTER, NORTHEAST QUARTER (SW ¼ NE ¼), SECTION THIRTEEN (13), TOWNSHIP ELEVEN (11) NORTH, RANGE FOURTEEN (14) WEST, CONTAINING 10 ACRES.

Section 2. The City shall provide fire and police services immediately upon this acceptance becoming effective. Other city services such as water and sewer services may be provided at a later date if such become available in the area.
