ORDINANCE NO.: 00-283

AN ORDINANCE CONFIRMING THE ANNEXATION ORDER  
OF THE COUNTY COURT DATED MAY 10, 2000;

WHEREAS, the real estate owners of portions of real property adjoining the City of Clinton desire to be annexed into the City; and,

WHEREAS, petitions in writing were filed with the County Court requesting that the City annex the contiguous lands into the City of Clinton; and,

WHEREAS, a court hearing was held on May 10, 2000, and the County Court approved the petitions and annexed the areas into the City of Clinton; and,

WHEREAS, the City of Clinton does desire, pursuant to Arkansas Code Annotated §14-40-605, to confirm the annexation.

NOW, THEREFORE, be it ordained by the City Council of the City of Clinton that the City of Clinton accepts the territory described below as territory annexed into the City of Clinton, to-wit:






