ORDER OF ANNEXATION

ON THIS DAY, same being _____day of July, 1986, this cause came on for hearing upon the Petition of Tammy Hawkins, asking that the hereinafter described lands be annexed to the City of Wynne, Arkansas, and the Court after being fully advised, finds:

- 1. Said Petition was filed more than thirty (30) days prior to this date, and notice thereof, together with notice of this hearing, has been published in the time, form and manner required by law, proof of publication of which has been filed herein.
- 2. Petitioner appointed Joseph Boeckmann, City Attorney, to act on here behalf in the filing and presentation of this Petition.
- 3. A majority of the total number of real estate owners in the area affected by this Petition have signed said Petition, and such majority owns more than one-half $(\frac{1}{2})$ of the acreage therein.
- 4. The territory sought to be annexed was accurately described in said Petition, is contiguous to the boundaries of the City of Wynne, Arkansas, and the map attached to said Petition is an accurate map of the territory sought to be annexed.
- 5. The prayer of Petition is right and proper, and said territory should be annexed to the City of Wynne, Arkansas.

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED that the following described lands be annexed to and made a part of the City of Wynne, Arkansas, to-wit:

ORDINANCE NO. #508

AN ORDINANCE ACCEPTING CERTAIN TERRITORIES AS A PART OF THE CITY OF WYNNE, ARKANSAS, AND ASSIGNING THE SAME TO AN EXISTING WARD.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WYNNE, ARKANSAS:

SECTION ONE: WHEREAS, pursuant to law, the owners of the following described properties contiguous to and adjoining the City of Wynne, Arkansas, to-wit:

have petitioned the County Court for the annexation of said properties to the City of Wynne, Arkansas. And whereas, the County Court, pursuant to law, has granted said Petition and confirmed same, the City of Wynne, through its City Council, hereby accepts the above described properties to be a part of the City of Wynne, Arkansas, and hereby extends the boundaries of the City of Wynne, Arkansas, to include the above described properties.

SECTION TWO: The above described properties, having been accepted as a part of the City of Wynne, Arkansas, the boundaries of the Wards of the City of Wynne are hereby amended as follows:

- a. WARD I: There is hereby added to Ward I the area described as all that part of Sections 4,5,8, and 9 lying West of North-South line of the Missouri Pacific Railroad and within the boundary of the City of Wynne.
- b. WARD IV: There is hereby added to Ward IV the area described as all of Section 17 lying North of the East-West line of the Missouri-Pacific Railroad and not presently within the City of Wynne.
- c. WARD III: There is hereby added to Ward III the area described as all that part of Sections 17 and 18 lying South of the East-West line of the Missouri-Pacific

Railroad and all of Sections 17, 18, 19, 20 and 24 lying South of the East-West line of the Missouri-Pacific Railroad and not presently within the City of Wynne.

SECTION THREE: Because of the need to immediately extend city police and fire protection to the area hereby annexed, an emergency is hereby declared and this Ordinance being necessary for the preservation of the public peace, health and safety shall be in force and take effect immediately upon its passage and approval.



ORDINANCE NUMBER 667

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF WYNNE, ARKANSAS AND MAKING SAME A PART OF THE CITY OF WYNNE AND ASSIGNING SAME TO WARDS.

WHEREAS, petition was filed with the County Clerk of Cross County, Arkansas, by the owners of hereinafter described territory praying that said territory be annexed to, and made a part of the City of Wynne, Arkansas; and,

WHEREAS, on August 5, 2004 the County Court of Cross County, Arkansas found that the petition was signed by owners of said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Wynne, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given for the time and manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Wynne, Arkansas subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time fixed by law for appealing from said order of annexation made by County Court has expired and no appeal has been taken from said order.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WYNNE, ARKANSAS:

SECTION 1: That the following described lands and territory contiguous and adjoining the City of Wynne, Arkansas, be and the same is hereby accepted as part of and annexed the City of Wynne:

A 47.04 tract of land lying in the East Half (E ½) of the Northwest Quarter (NW ¼) and the South Half (S ½) of the Northeast Quarter (NE ¼) of Section 24, Township Seven North (T7N), Range Two East (R2E), Cross County, Arkansas and being more particularly described as:

Beginning at the center of Section 24, T7N, R2E, thence along the South line of the NW ¼ of said Section 24 South 87 degrees 16 minutes 26 seconds West 640.39 feet to a point, thence North 00 degrees 24 minutes 05 seconds East 2719.82 feet to a point lying on the North line of said NW ¼ of Section 24, thence along said North line of Section 24 North 85 degrees 49 minutes 43 seconds East 640.39 feet to the Northeast corner of the NW ¼ of Section 24, thence along the East line of said NW ¼ of Section 24 South 00 degrees 22 minutes 44 seconds West 1372.39 feet to the Northwest corner of the S ½ of the NE ¼ of Section 24, thence along the North line of the S ½ of said NE ¼ of Section 24 North 85 degrees 32 minutes 26 seconds East 1885.52 feet to a fence being the West boundary of the Wynne Water Treatment Facility, thence along the facility boundary South 00 degrees 22 minutes 44 seconds West 160.00 feet to a point, thence South 85 degrees 32 minutes 36 seconds West 1885.52 feet to a point lying on the East line of the NW ¼ of Section 24, thence along said East line of said NW1/4 of Section 24 South 00 degrees 22 minutes 44

seconds West a distance of 1203.55 feet to the Point of beginning, containing 47.04 acres more or less, LESS AND EXCEPT a cemetery lying in the E ½ of the NW ¼ of Section 24, T7N, R2E, being more particularly described as: Commencing at the center of Section 24, T7N, R2E, thence South 87 degrees 16 minutes 26 seconds West 245.23 feet to a point, thence North 24 degrees 58 minutes 40 seconds East 588.25 feet to a point, thence South 00 degrees 22 minutes 24 seconds West 521.58 feet to the point of beginning, containing 1.47 acres more or less and containing 45.57 acres after exception, and being subject to all easements, rights of way and restrictions of record.

SECTION 2: That the above described territory shall be annexed to and made a part of Ward Three, zoned Residential 1 (R1), of the City of Wynne, and the same shall henceforth be part of said ward as fully as existing parts of said ward.
