




Arkansas Code 14-40-101.

ORDINANCE NO. 102

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF GRIFFITHVILLE, ARKANSAS

WHEREAS, there has been presented to the County Court of White County, Arkansas, the petition of a number of property owners requesting that certain property hereinafter described, which lies adjacent to and adjoins the City Limits of the City of Griffithville, Arkansas, be annexed to and made a part of said city; and

WHEREAS, the County Court of White County, Arkansas, has determined that said Petition has in all things, conformed with the laws applicable thereto, approved the Petition and issued an Order on the 6 day of April 1968, therein approving the annexation of the property hereinafter described, and making said property a part of said City, the Order having been recorded in County Book        Page       , of the records of White County, Arkansas, and said Order of annexation having been entered subject to approval and acceptance by the City Council of the City of Griffithville, Arkansas; and

WHEREAS, said City Council of the City of Griffithville, Arkansas finds that the aforesaid Petition and Order of Annexation does, in all things, conform to the laws pertaining thereto and that it would be for the best interest of said City that the property herein described be annexed to and made a part of the City of Griffithville, Arkansas now, therefore,

BE IT HEREBY ORDAINED AND ADOPTED BY THE CITY OF GRIFFITHVILLE, ARKANSAS BY THE CITY COUNCIL IN MEETING ASSEMBLED:

1. That the Order of Annexation entered by the County Court of White County, Arkansas, on April 6, 1968, be and the same hereby is approved, confirmed, and ratified, and the following described property, to-wit:

The East 5 chains of the West Half ( $W\frac{1}{2}$ ) of Southeast Quarter ( $SE\frac{1}{4}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section 21, Township 6 North, Range 6 West

be and the same hereby is, accepted as an annexation to the City of Griffithville, Arkansas.

2. That certified copies of the entire proceedings relative hereto be filed with the City Council of the City of Griffithville, Arkansas, the Secretary of State, Little Rock, Arkansas, and any other agency as required by law.
