### ORDINANCE # 2010-03

AN ORDINANCE SUBMITTING TO THE VOTERS OF THE CITY OF HIGGINSON, ARKANSAS AND OTHER AFFECTED PERSONS, THE QUESTION OF ANNEXATION TO SAID CITY OF HIGGINSON, ARKANSAS OF CERTAIN CONTIGUOUS TERRITORY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Mayor of the City of Higginson, Arkansas and the City Council in and for the City of Higginson have, after due considerations, determined that certain hereinafter described territory contiguous to the City of Higginson, Arkansas is necessary for the orderly growth of said City; and

WHEREAS, a portion of the lands are platted and held for sale or use as municipal lots or, whether platted or not, a portion of the lands are held to be sold as suburban property; and

WHEREAS, the lands furnish the abode for a densely settled community or represent the actual growth of the City of Higginson, Arkansas beyond its now existing legal bearing; and

WHEREAS, the lands are needed for proper municipal purposes such as for the extension of needed municipal services; and

WHEREAS, the lands are valuable by reason of their adaptability for prospective municipal uses, as residences and commercial property; and

NOW THEREFORE, be it ordained by the City Council of the City of Higginson, Arkansas:

Section 1. That there shall be submitted to the qualified electors of the City of Higginson and of the area described in Exhibit No. 1, the question of the anaexation of the above described territory to the City of Higginson, Arkansas. (A map outlining the area proposed for annexation is attached hereto as Exhibit No. 2, and is incorporated herein by reference as though set forth word for word.)

Section 2. The question of annexation of the territory described above in Section 1, shall be submitted to the electors qualified to vote on November 2<sup>nd</sup>, 2010 in the general election. The Clerk for the City of Higginson, Arkansas shall immediately notify the White County Election Commission by forwarding a certified copy of this ordinance.

Section 3. If at such election a majority of the qualified electors voting in such election shall vote for such annexation, the municipality shall proceed to file a description and a map of the annexed area with the County Clerk of White county and with the Secretary of State of the State of Arkansas. The annexation shall be included within the corporate

limits of the annexing city thirty (30) days following the filing of the description and map with the County Clerk, or in the event an action is filed with the Circuit Court, on the date the judgment of said Court becomes final. If a majority of the qualified electors voting on the issue at the November 2<sup>nd</sup>, 2010 general election vote against the annexation the annexation ordinance shall be null and void.

Section 4. The ballots used at the November  $2^{nd}$ , 2010 general election on the question of annexation shall be marked as follows:

Section 5. If the annexation into the City of Higginson, Arkansas is approved and becomes final, the following services shall be extended to the area within three (3) years:

Section 6. The Mayor and City Clerk are authorized to take all steps necessary for placing this measure on the ballot at the November 2<sup>nd</sup>, 2010 general election.

Section 7. EMERGENCY CLAUSE. The City Council for the City of Higginson, Arkansas finds that the immediate implementation of this ordinance is necessary to give the City of Higginson, the White County Clerk and the White County Election Commission sufficient time to prepare for the election contemplated herein to be held at the general election on November 2<sup>nd</sup>, 2010 in accordance with the provisions of Ark. Code Ann. ~14-40-303, and that because of the limited time that an emergency exists and that it is, therefore declared that this ordinance is necessary for the preservation of the public peace, health, safety and welfare and shall be in full force and effect from its passage.




