





Arkansas Code 14-40-101.






AN ORDINANCE APPROVING THE ANNEXATION OF CERTAIN
PROPERTY INTO THE CITY LIMITS OF IMBODEN, ARKANSAS

Be it ordained by the City Council of Imboden, Arkansas:

1.

That the order filed by the County Court annexing certain property into the city of Imboden is hereby approved and the annexation is gratified by the City Council.

2.

The property to be annexed is described as follows:

All that part of the Northwest Quarter (NW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) and all that part of the Southwest Quarter (SW $\frac{1}{4}$) of Section Fourteen (14), and all that part of the North Half (N $\frac{1}{2}$) of Section Twenty-three (23), and all that part of the North Half (N $\frac{1}{2}$) of the South Half (S $\frac{1}{2}$) of Section Twenty-three (23), lying and being situated between the right of way of the St. Louis-San Francisco Railroad on the North and East and U. S. Highway No. 63 on the South and West and East of the Corporate limits of the Town of Imboden, Arkansas, containing 204 acres, more or less, all being in Township Eighteen (18) North, Range Two (2) West.

3.

The clerk shall forward one copy of the documents concerning this annexation to the secretary of state and shall maintain a copy in the permanent records of the city of Imboden.
