ORDINANCE NO. 5

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE TOWN OF GARNER, WHITE COUNTY ARKANSAS, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, there has been presented to the County Court of White County, Arkansas, a petition from certain property owners requesting that the real property, hereinafter described, which property lies contiguous with, adjacent to, and adjoins the present corporate limits of the Town of Garner, White County, Arkansas, be annexed to, and made a part of said town; and

WHEREAS, the County Court of White County, Arkansas, has determined that the petition has in all things conformed with the laws applicable thereto, and has approved the petition and issued an order on February 27, 1973, therein approving the annexation of the property and making the property a part of the Town of Garner, White County, Arkansas, the Order having been recorded in County Book V at Page 189, of the Records of White County, Arkansas, and said Order of Annexation having been entered subject to approval and acceptance by the Town Council of the Town of Garner, White County, Arkansas; and

NOW THEREFORE BE IT HEREBY ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GARNER, ARKANSAS

SECTION 1: The Order of Annexation, entered by the County Court of White County, Arkansas, on February 27, 1973, be, and the same hereby is approved, confirmed and ratified, and the following described real property, to-wit:




