





Arkansas Code 14-40-101.

RESOLUTION 98-02

WHEREAS, the City of Corning has had petitioned by citizens for annexation to the City of Corning, Arkansas, and,

Whereas, the County Judge has heard the Petition pursuant to law and,

Whereas, the County Judge has entered an order annexing said properties to the City of Corning, Arkansas.

NOW THEREFORE, BE IT RESOLVED, that the City Counsel, City of Corning, Arkansas accepts the attached Order of the County Judge and said lands be and the same are hereby accepted and said properties are hereby annexed to the City of Corning, Arkansas, same being:

All that part of the NW 1/4 of Section 31 Township 21 North, Range 5 East which lies East of Highway 67 and all that part of the NE 1/4 of Section 31 Township 21 North, Range 5 East that lies North of and joining the City limits of Corning, and West of the Union Pacific Railroad as laid out and existing; and the SE 1/4 of Section 30, Township 21 North, Range 5 East and all that part of Section 6, Township 20 North, Range 5 East that lies North of Highway 62 and all that part of the NW 1/4 of Section 5, Township 20 North, Range 5 East, SAVE AND EXCEPT 3 acres (King), in the SE corner thereof, bordered on the East by a County Road as laid out and existing, and on the South by Highway 62 and all that part of the S 1/2 of the SW 1/4 of Section 32, Township 21 North, Range 5 East lying South and East of Victory Lake, all of which lands are contiguous to and border the existing City limits of the City of Corning, Arkansas; and all that part of the S 1/2 of the NW 1/4 of Section 29; and all that part of the SW 1/4 of Section 29 that lies West of Union Pacific Railroad as laid out and existing, same being a part of Section 29, Township 21 North, Range 5 East. AND

The S 1/2 of the NE 1/4 of Section 36, Township 21, Range 4 and all that part of Section 1, Township 20 North, Range 4 East described as: [A part of the S 1/2 of Section 1 being described as commencing at the SE 1/4 of the NE 1/4 of the SE 1/4 of Section 1 at the point of intersection with the ditch as laid out and existing; thence West and along the quarter section line and the center of the ditch to the point where the ditch turns North and through the NW 1/4 of the SW 1/4 of said Section 1; thence continue through the ditch along the ditch to the point of intersection with Highway 67 West.]

It is the express purpose that all property lying North and East of Cypress Ditch in Section 1 be included in the Petition for Annexation as the ditch is laid out and existing.




