ORDER CONFIRMING ANNEXATION

On this 22nd day of May 2020, came on the Petitioners, Stephen Sprick and Erin Hunter, and for their Petition for Annexation of the real property located at 224 S. Treating Plant Rd., De Queen, Arkansas, the Court does find the following:

1. The property subject to this annexation into the City of De Queen, Arkansas is:

NE1/4 of NE1/4 of Section 35, Township 8 South, Range 32 West, Sevier County, Arkansas.

- 2. The property to be annexed meets all of the requirements under A.C.A. §14-40-609. Said land is contiguous to the city limits of De Queen, Arkansas, and if annexed, no enclaves would be created. Part of such real property is already located within the city limits of the City of De Queen, and City Services are already being provided to the real property.
- 3. The Petitioners, Stephen Sprick and Erin Hunter, have complied with all requirements under A.C.A. \$14-40-609 in that they have filed a verified petition, such petition contained the legal description seeking annexation, they have provided a title commitment for title insurance as well as a letter from a certified abstractor stating they are the only legal owners of the real property, and a letter from a certified surveyor stating that such real property is contiguous to the current city limits of the City of De Queen, and that that no enclaves shall be created. A schedule of services was also contained in such petition for annexation on behalf of the Petitioners.
- **4.** No public roads abut or transverse such real property, therefore no dedication of said roads shall be required by the Sevier County Court.




