



A JOINT ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAUMELLE, AND THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, COUNTY OF PULASKI, STATE OF ARKANSAS

A JOINT ORDINANCE TO BE TO BE ENTITLED:

ORDINANCE NO 736

A JOINT ORDINANCE FOR THE SIMULTANEOUS DETACHMENT AND ANNEXATION OF LAND SITUATED ALONG STATE HIGHWAY 100 TO BE TITLED THE "2010 COLLINS ANNEXATION" TO THE CITY OF MAUMELLE, ARKANSAS, AND FOR THE SIMULTANEOUS DETACHMENT AND ANNEXATION OF LAND SITUATED ALONG CORONDELET LANE, TO BE TITLED THE "2010 COUNTRY CLUB DEVELOPMENT" ANNEXATION TO THE CITY OF NORTH LITTLE ROCK, AND MAKING THESE ANNEXATIONS A PART OF THE CITY OF MAUMELLE AND THE CITY OF NORTH LITTLE ROCK RESPECTIVELY, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES.

WHEREAS, the Cities of North Little Rock and Maumelle (the "Cities") are municipal neighbors which share a number of common borders. Certain of the common borders are situated in such a way as to create confusion for emergency and city personnel.

WHEREAS, Parcel A consists of land situated on State Highway 100 (Maumelle Boulevard) which is presently within the corporate boundary of the City of North Little Rock, Arkansas but lies contiguous to and adjoining the corporate boundary of the City of Maumelle on three of the four sides of the property.

WHEREAS, Parcel B consists of land situated in the north eastern portion of the subdivision known as Country Club of Arkansas on Corondelet Lane; this parcel is presently within the corporate boundary of the City of Maumelle, Arkansas but lies contiguous to and adjoining the corporate boundary of the City of North Little Rock on three of the four sides of the property.

WHEREAS, this joint ordinance will serve to clarify the boundaries and will facilitate stronger emergency responses and provisions of city services from both cities by ending situations where great confusion could and often does, arise.

WHEREAS, via this joint ordinance, the Cities agree to detach said lands pursuant to Act 988 of 1999, which is codified as Ark. Code Ann. § 14-40-2010 so that the lands may be simultaneously annexed into the Cities by virtue of the same authority; and

WHEREAS, the City Council of the City of Maumelle finds that it is in the best interest of the City, for the lands identified as Parcel A to be detached from the City of North Little Rock and simultaneously annexed into the City of Maumelle and for that land identified as Parcel B to be detached from the City of Maumelle and simultaneously annexed into the City of North Little Rock.

WHEREAS, the City Council of the City of Maumelle finds that it is in the best interest of the City, for the lands identified as Parcel A to be detached from the City of North Little Rock and simultaneously annexed into the City of Maumelle and for that land identified as Parcel B to be detached from the City of Maumelle and simultaneously annexed into the City of North Little Rock.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MAUMELLE, ARKANSAS AND BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK:

SECTION 1. Parcel A. That the following described lands [Parcel A] contiguous to and adjoining the City of Maumelle, Arkansas, be, and the same are hereby, simultaneously detached from the City of North Little Rock and accepted as part of and annexed to and made a part of the City of Maumelle. Said parcel shall be annexed with a zoning of PCD (Planned Commercial Development) and shall be allowed one curb cut off Maumelle Boulevard. The location of the curb cut shall be determined by a site plan at the time of development and approval for the same must also be obtained from the Arkansas Highway and Transportation Department prior to installation:

SECTION 2. <u>Parcel B.</u> That the following described lands [Parcel B] contiguous to and adjoining the City of North Little Rock, Arkansas, be, and the same are hereby, simultaneously detached from the City of Maumelle and accepted as part of and annexed to and made a part of the City of North Little Rock:

- SECTION 3. <u>Repealer</u>. That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.
- SECTION 4. <u>Severability</u>. The provisions of this Ordinance are hereby declared to be severable and if any section or phrase or provision should be declared to be or held invalid, such invalidity shall not effect the remainder of such sections, phrases or provisions.
- SECTION 5: Emergency Declared. It is hereby found by the City Council of the City of Maumelle, Arkansas, that an emergency exists and that there is an immediate need to go forward with this annexation in order that the necessary municipal services may be provided the property and that undue delay will damage the property owner. THEREFORE, an emergency is declared to exist and this Ordinance being immediately necessary for the promotion and preservation of the public peace, health, and safety shall be in full force and effect immediately after its passage and approval.



ARKANSAS, AND FOR THE SIMULTANEOUS DETACHMENT AND ANNEXATION OF LAND SITUATED CORONDELET LANE, TO BE TITLED THE "2010 COUNTRY CLUB DEVELOPMENT" ANNEXATION TO THE CITY OF NORTH LITTLE ROCK, MAKING THESE ANNEXATIONS A PART OF THE CITY OF MAUMELLE AND THE CITY OF NORTH LITTLE ROCK, RESPECTIVELY; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, the Cities of North Little Rock and Maumelle (the "Cities") are municipal neighbors which share a number of common borders. Certain of the common borders are situated in such a way as to create confusion for emergency and city personnel, and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the lands identified as Parcel A contiguous to and adjoining the City of Maumelle, Arkansas, more particularly described in Exhibit "A" attached hereto and incorporated by reference, be, and the same are hereby, simultaneously detached from the City of North Little Rock and accepted as part of and annexed to and made a part of the City of Maumelle.

SECTION 2: That the lands identified as Parcel B contiguous to and adjoining the City of North Little Rock, Arkansas, more particularly described in Exhibit "B" attached hereto and incorporated by reference, be, and the same are hereby, simultaneously detached from the City of Maumelle and accepted as part of and annexed to and made a part of the City of North Little Rock.

SECTION 3: That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

SECTION 4: That the provisions of this Ordinance are hereby declared to be severable and if any section, phrase or provision shall be declared or held invalid, such invalidity shall not affect the remainder of the sections, phrases or provisions.

SECTION 5: It is hereby found and determined that there is an immediate need to go forward with this annexation in order that the necessary municipal services may be provided the property and that undue delay will damage the property owner; THEREFORE, an emergency is declared to exist, and this Ordinance being immediately necessary for the promotion and preservation of the public peace, health, and safety shall be in full force and effect immediately after its passage and approval.




