
WHEREAS, the proposed annexation has been advertised in accordance with law; and

WHEREAS, no objection to said annexation has been made; and


WHEREAS, said annexation requires the consent of the City of Alma, through its City Council, to become operative:

On this 30 day of January, 1953 is presented to this court the petition of the State Highway Commission of the State of Arkansas, asking for changes, in part to the order of Crawford County Court, made on May 26, 1952, and appearing of record in Book "Q" at page 61, on the Alma-Bypass Road, Highway Job No. 4367, Federal Aid Project No. FI-216(8), State Highway No. 64, Section 2, in Sections 5 and 6, Township 9 North, Range 30 West, said road being commonly known here as the Alma-Bypass Road.

It is represented to this court that for the purpose of constructing, improving and maintaining this road economically and for the best service, convenience, welfare and safety of the traveling public, to provide area for the machinery and equipment for the construction or maintenance, for such changes as might be necessary for drainage or changes in design; size, weight and speed of vehicles and the traffic laws and customs, to care for erosion, sight distance, public utilities installations and to prevent the erection of dangerous structures too close to the highway, it is deemed necessary by the State Highway Commission of the State of Arkansas that the location and width of the right of way of said road be changed in whole or in part in accordance with the following description and the plats filed herewith.

Starting at the Northwest corner of the Southwest Quarter of the Southeast Quarter of Section 6, Township 9 North, Range 30 West; thence due North 68.0 feet to a point on tangent of Job No. 4333 as surveyed by the Arkansas Highway Commission, said point designated as station 331+52.4; thence N 64°12'E 1399.2 feet to station 345+51.6 for a point of beginning.

Beginning at station 345+51.6, the above described point; thence N 64°12'E 3428.5 feet to Station 379+80.1; thence along a 3 degree curve right 523.9 feet to station 385+04.0; thence N 79°55'E 658.9 feet to station 391+62.9; thence along a 3 degree curve right 414.4 feet to station 395+77.3; thence S 87°39'E 1622.7 feet to station 412+00 and the end of this centerline description.
