ORDINANCE NO. 2019 - 3

AN ORDINANCE ANNEXING CERTAIN LANDS THAT ARE COMPLETED AND PROBATE SURROUNDED BY THE INCORPORATED LIMITS OF THE CITY OF ALTUS, ARKANSAS; DECLARING AN

EMERGENCY: AND FOR OTHER PURPOSES.

WHEREAS, Arkansas Code Annotated sections 14-40-501—14-40-503 provide that unincorporated islands of land that have been surrounded by the incorporated limits of a municipality may be annexed by that municipality, including situations in which the unincorporated area is surrounded on three sides by the municipal boundaries and on the fourth side by a state boundary, a military base, a state park, a national forest, a lake or a river.

WHEREAS, the City of Altus desires to annex certain lands more completely described below; and WHEREAS, all necessary urban services, such as fire and police protection, are to be extended to such area within a reasonable period of time; and

WHEREAS, the area to be annexed complies with the standards for lands qualifying for annexation which are set forth in A.C.A. § 14-40-302 and A.C.A. § 14-40-501; and

WHEREAS, the council finds that the territory to be annexed is considered an enclave since Tract 1 is surrounded by the incorporated limits of the City of Altus on all four sides and Tract 2 is surrounded on three sides by the municipal boundaries and on the fourth side by a majority portion of the city limits; and

WHEREAS, the council further finds that the territory consists of lands that:

- (1) Represent the actual growth of the municipality beyond its legal boundary; and
- (2) Are needed for proper municipal purposes such as for the extension of needed police regulation; and


WHEREAS, a public hearing was held on September 6, 2019, regarding this proposed annexation; and

WHEREAS, on August 21, 2019, a legal notice was published setting out the legal description of the territory proposed to be annexed, and all property owners within the area were notified by certified mail of their right to appear at the public hearing.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ALTUS, ARKANSAS: SECTION 1. That the following described unincorporated area which is completely surrounded by the city limits of the City of Altus, Arkansas, is hereby annexed to the City of Altus:

(Tract 1) A certain tract of land located in the South half of the Northwest Quarter of the Northwest Quarter of Section 22, Township 09 North, Range 26 West being more particularly described as follows: Commencing at a Spike at the NE Corner of the NW/4 of the NW/4 of said Section 22; THENCE: S 02 degrees 46 minutes 00 seconds West 662.35 feet along the East Line of said NW/4 of the NW/4 to the NE Corner of said S/2 of the NW/4 of the NW/4; THENCE: N 87 degrees 06 minutes 31seconds West 20.00 feet along the North Line of said S/2 of the NW/4 of the NW/4 to a Spike, the Point of Beginning; thence South 02 degrees 46 minutes 00 seconds West 197.00 feet to a 1/2 inch rebar; thence North 87 degrees 06 minutes 31 seconds West 221.50 feet to a 1/2 inch rebar; thence North 02 degrees 46 minutes 00 seconds East 197.00 feet to a 1/2 inch rebar on the North Line of said S/2 of the NW/4 of the NW/4; THENCE: South 87 degrees 06 minutes 31 seconds East 221.50 feet to the Point of Beginning.

(Tract 2) A CERTAIN TRACT OF LAND LOCATED IN THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 22, TOWNSHIP 9 NORTH, RANGE 26 WEST IN THE CITY OF ALTUS IN FRANKLIN COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS AND AS SHOWN ON ARKANSAS RIVER VALLEY SURVEYING PLAT #2935: COMMENCING AT A SPIKE AT THE NE CORNER OF SAID NW/4 OF THE NW/4; THENCE SOUTH 02 DEGREES 46 MINUTES 00 SECONDS WEST 1050.76 FEET ALONG THE EAST LINE OF SAID NW/4 OF THE NW/4; THENCE NORTH 89 DEGREES 59 MINUTES 38 SECONDS WEST 340.69 FEET PARALLEL TO THE NORTH LINE OF SAID NW/4 OF THE NW/4 TO AN IRON PIPE, THE POINT OF BEGINNING; THENCE SOUTH 03 DEGREES 20 MINUTES 32 SECONDS WEST 261.30 FEET TO A 1/2 INCH


