ORDINANCE NO. 46 OF 2016

AN ORDINANCE ANNEXING CERTAIN TERRITORY INTO THE CORPORATE LIMITS OF THE CITY OF BENTON, SALINE COUNTY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, the Duke Family Limited Partnership, LLP, as property owner, filed a petition with the County Court of Saline County, Arkansas, to annex certain contiguous property hereinafter described, into the corporate limits of the City of Benton, Saline County, Arkansas, and

WHEREAS, on the 26th day of July, 2016, Jeff Arey, Saline County Judge, determined that said petition should be granted and that the property hereinafter described should be released from Saline County and annexed to the corporate limits of the City of Benton, Saline County, Arkansas; and

WHEREAS, more than thirty (30) days has expired since entry of said order and the City of Benton desires to accept said property into the City,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BENTON, ARKANSAS:


<u>SECTION 1:</u> The property hereinafter described be annexed and made a part of the City of Benton, Saline County, Arkansas, and is to be included in Ward 2 and zoned as CH- Commercial Highway and is described as follows, to wit:

THAT PART OF THE NORTH HALF OF SECTION 20 AND THAT PART OF THE SOUTHEAST QUARTER OF SECTION 17, ALL IN TOWNSHIP 2 SOUTH, RANGE 15 WEST, SALINE COUNTY, ARKANSAS, DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 20; THENCE SOUTH 89°13'23" WEST ALONG THE SOUTH LINE THEREOF 1358.25 FEET TO THE POINT OF BEGINNING; THENCE NORTH 89°13'23" WEST CONTINUING ALONG SAID SOUTH LINE 617.82 FEET; THENCE NORTH 22°16'32" EAST 136.87 FEET; THENCE NORTH 67°43'28" WEST 309.78 FEET TO A POINT ON THE EAST RIGHT OF WAY LINE OF HIGHWAY 67; THENCE ALONG SAID EAST RIGHT OF WAY LINE OF HIGHWAY 67 THE FOLLOWING COURSES: NORTHERLY ALONG SAID RIGHT OF WAY LINE 94.50 FEET ALONG A CURVE CONCAVE WESTERLY HAVING A RADIUS OF 4513.95 FEET SAID CURVE HAVING A CHORD DIRECTION OF NORTH 17°51'44" EAST AND A CHORD LENGTH OF 94.50 FEET; THENCE NORTH 17°15'45" EAST 720.73 FEET TO A POINT ON THE EAST RIGHT OF WAY LINE OF INTERSTATE 30; THENCE ALONG SAID EAST RIGHT OF WAY LINE OF INTERSTATE 30 THE FOLLOWING COURSES: NORTH 48°01'54" EAST 511.91 FEET TO A POINT ON THE SOUTH LINE OF SECTION 17; THENCE NORTH 48°01'54" EAST 264.87 FEET; THENCE SOUTH 01°11'15" EAST LEAVING SAID RIGHT OF WAY LINE OF INTERSTATE 30 FOR 1550.45 FEET TO THE POINT OF BEGINNING. 

DECREE OF ANNEXATION

Comes for hearing the Petition of Duke Family Limited Partnership, LLP, who is the one hundred percent (100%) property owner of portions of Section 20 and Section 17, Township 2 South, Range 15 West, asking that the following territory be annexed to the City of Benton, Saline County, Arkansas, towit:

LEGAL DESCRIPTION, SEE ATTACHED EXHIBIT "A"

The area to be annexed is to include all adjacent and abutting public streets and rights of way. After hearing the evidence, the Court finds:

- 1. That the Petition for Annexation is attested by the property owner;
- 2. That the boundaries of said territory have been accurately described within the petition;
- 3. That said land is adjacent and contiguous to the City of Benton, Saline County, Arkansas and provides for contiguity of access;
- 4. That said petition contained all required verifications and is complete and accurate;
- 5. That no enclaves will be created by the annexation;
- 6. That said petition contains a schedule of services; and
- 7. That said petition should be granted and the territory as above described should be annexed to the City of Benton, Saline County, Arkansas, and become part of said City.
