A RESOLUTION TO ANNEX A 32.82 ACRE TRACT OF LAND TO THE CITY OF BRINKLEY, MONROE COUNTY, ARKANSAS, AND TO CLASSIFY SAID 32.82 ACRE TRACT IN THE RESIDENTIAL ZONING CLASSIFICATION OF "R-1".

WHEREAS, It is necessary for the continued growth and development of the economy of the City of Brinkley, that its corporate limits be increased and expanded; and,

WHEREAS, the lands sought to be annexed are contiguous and adjacent to the City Limits of the City of Brinkley, and the Petitioner seeking annexation is the sole owner of the lands sought to be annexed and has caused to be made a survey of such contiguous territories as specifically described as follows:



ORDER CONFIRMING ANNEXATION

On this 14th day of December, 1998, the Court is presented the Order Granting Annexation heretofore entered on the 9th day of November, 1999, upon the Petition for Annexation of Lands to the City of Brinkley, Monroe County, Arkansas, filed herein, the Petitioner appearing by and through its attorneys, Elledge and Martin, and by the Consent of the property owner, CLA-CLIF NURSING & REHAB CENTER, INC., and statements of counsel, the Court, being well and sufficiently advised, finds:

1. The Petitioner, CLA-CLIF NURSING & REHAB CENTER, INC., is the sole owner of all of the lands sought to be annexed to the City of Brinkley, Monroe County, Arkansas, more particularly described as follows:

Part of the South Half of the South Half of the Northwest Quarter (S2 S2 NW4), Section 23, Township 3 North, Range 2 West, and being more particularly described as follows: Commence at the Northwest corner of said Section 23; thence South 00°46'11" West along the West line thereof a distance of 1,979.30 feet to the Northwest corner of the said S_2^{1} S_2^{1} NW_4^{1} ; thence South 89°34'06" East along the North line of said S_2^1 S_2^1 NW_4^1 , a distance of 630.28 feet for a point of beginning; thence continue South 89°34′06" East along said North line, a distance of 1,430.49 feet to the West right of way line of an asphalt county road; thence South 21°16'17" East along said right of way line, a distance of 710.34 feet to the South line of said S1/2 S1/2 NW1/4; thence North 89°34'06" West along said South line a distance of 1,696.96 feet; thence North a distance of 660.00 feet to the point of beginning, containing 25.78 acres, more or less,

AND ALSO, Part of the North Half of the South Half of the Northwest Quarter (N½ S½ NW¼), Section 23, Township 3 North, Range 2 West, and being more particularly described as follows: Commence at the Northwest corner of said Section 23; thence South 00°46′11" West along the West line thereof, a distance of 1,979.30 feet to the Northwest corner of the said S½ S½ NW¼; thence South 89°34′06" East along the North line of said S½ S½ NW¼, a distance of 630.28 feet for a point of beginning; thence continue South 89°34′06" East along said North line, a distance of 1,430.49 feet to the West right of way line of an asphalt county road; thence North 21°16′17" West along said right of way line, a distance of 94.74 feet to a point; thence North 89°01′20" West a distance of 1,450.43 feet; thence South 00°46′11" West a distance of 37.00 feet to the point of beginning, containing 7.04 acres, more or less.

- 3. The Petitioner is the sole property owner of the above described lands and therefore constitutes more than the requisite majority of property owners as provided by A.C.A. §14-40-601.
- 4. The lands are contiguous and adjacent to the city limits of the City of Brinkley, Monroe County, Arkansas.
- 5. There have been no objections filed in opposition to the Order granting of the Petition for Annexation. No action has been filed in the Monroe County Circuit Court seeking to prevent the annexation.
- 6. The Order of this Court granting of the Petition for Annexation is hereby confirmed.

IT IS THEREFORE, BY THE COURT, CONSIDERED, ORDERED AND ADJUDGED, that the following lands be and hereby are annexed into the city limits of the City of Brinkley, Monroe County, Arkansas, subject to the provisions of confirmation as provided by A.C.A. § 14-40-605, said lands being more fully described as follows:
