AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF BENTONVILLE, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF BENTONVILLE, AND ASSIGNING SAME TO WARDS.

WHEREAS, petition was filed with the County Clerk of Benton County, Arkansas by all of the owners of the hereinafter described territory, said owners being listed in Exhibit "A" to this ordinance, praying that said territory be annexed to, and made a part of the City of Bentonville, Arkansas, and

WHEREAS, on the <u>1st</u> day of <u>August</u>, 2019, the County Court of Benton County, Arkansas, entered an order authorizing annexation pursuant to § 14-40-609 of the Arkansas Code, finding that the petition met the requirements for annexation under that provision and directed the Clerk to forward the order to the Mayor of the City of Bentonville; and

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BENTONVILLE, ARKANSAS:

Section 1. That the land described on the attached Exhibit "B," which includes both the territory sought to be annexed by the petitioners and the dedicated public roads and rights of way abutting or traversing the property proposed to be annexed, is territory contiguous to and adjoining the City of Bentonville, Arkansas, and the petition to annex that property is hereby granted and the property described in Exhibit "B" is hereby accepted as part of and annexed to and made a part of the City of Bentonville.

Section 2. That the above described territory shall be annexed to and made a part of 2019 SEP 26 PM Ward 2 of the City of Bentonville, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 3. That the above described territory shall be zoned ____A-1__, to be used in accordance with City zoning laws and the laws of the State of Arkansas.

Section 4: That this ordinance shall become effective 30 days from its passage and approval.







Hi Jennifer,

Our policy would be the same as the one we adopted for other nonstandard annexations, or apparently unlawful annexations that could be potentially challenged in court by the appropriate parties with standing: we would do what we could to encourage the municipality to follow the code but ultimately will file any complete annexation package that is sent to us, as long as all the requisite documents are

In the case of enclaves, the language prohibiting the creation of them only says that "Whenever practicable," the annexation of contiguous lands should not create enclaves (§14-40-504(b), §14-40-302(d)(1)). While it's arguable that annexation of part of an existing enclave, leaving a smaller enclave, could be construed as "creating" an enclave, a municipality should be prepared to explain to potentially interested parties why annexation of the whole was "impracticable."

That said, I am not aware of any statute prohibiting annexation of part of an enclave, and I have been unable to find any case law on point either. So as long as the city followed the proper protocol with respect to notice, vote/petition, certification by county, etc., we would file it.

Let me know if that doesn't answer your question!

As I understand it, if the county judge and the mayor agree on annexing only part of the enclave, that has to be made explicitly clear in the language of the ordinance and the court order.


