### **RESOLUTION NO. 1058**

### A RESOLUTION ACCEPTING THE ANNEXATION OF CERTAIN-TERRITORY TO THE CITY OF BERRYVILLE; APPROVING THE SCHEDULE OF SERVICES TO BE EXTENDED TO SAID AREA; AND ASSIGNING SUCH TO WARDS

WHEREAS, a petition was filed, pursuant to A.C.A. § 14-40-609, for the annexation of certain territory into the City of Berryville, Arkansas; and

WHEREAS, the Carroll County Assessor and the Carroll County Clerk have (A) Verified the identity of the petitioner(s); (B) Verified that there are no property owners included in the petition that do not wish to have their property annexed; (C) Verified that the property or properties are contiguous with the City; (D) Verified that no enclaves will be created if the petition is accepted by the City; and presented the petition and their respective verifications to the Carroll County Judge; and

WHEREAS, the County Judge has (A) reviewed the petition and verifications for completeness and accuracy; (B) determined that no enclaves will be created by the annexation; (C) confirmed that the petition contains a schedule of services; (D) found that the land to be annexed consists of lands that furnish the abode for a densely settle community or represent the actual growth of the municipality beyond its legal boundary, and are valuable by reason of their adaptability for prospective municipal uses; and (E) issued an order articulating these findings and forwarded the petition and order to the contiguous City of Berryville for consideration; and

WHEREAS, it is the desire of the City Council of Berryville that said territory be annexed.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BERRYVILLE, ARKANSAS:

<u>Section 1.</u> That the following described territory, contiguous to the City of Berryville, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Berryville, Arkansas:

Those approximately 50 acres not already within the corporate limits of the City of Berryville, Arkansas within the following described real property: The NE ¼ of the SE ¼ of Section 31, and the N ¼ of the NW ¼ of the SW ¼ of Section 32, Township 20 North, Range 24 West, Carroll County, Arkansas, containing 60 acres, more or less, lying on the West side of AR Highway 21.

Section 2. That the following schedule of services shall be extended to the area by the City of Berryville within the statutorily required three (3) year period after the date the annexation becomes final, as follows: 20.9 - 653

- 1) City of Berryville Fire Department protection immediately upon annexation;
- 2) City of Berryville Police Department protection immediately upon annexation;
- 3) City of Berryville Water Department service within 1 year of annexation;
- 4) City of Berryville Sewer Department service within 1 year of annexation.

Section 3. That the above described territory shall be annexed to and made a part of Ward 2 of the City of Berryville, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

Section 4. Thirty (30) days after passage and publication or posting of this Resolution as authorized by law, the annexation shall be final and the property shall be within the corporate limits of the City, except as otherwise ordered by the Circuit Court pursuant to a cause of action filed within said thirty (30) day period.

Section 5. Notice. Within forty-five (45) days of the effective date of this resolution the City Clerk shall provide written notice, along with complete documentation, to the County Clerk of each county in which the territory is affected.

City of Sherwood</u>, 375 Ark. 107, 110 (Ark. 2008).




