

A RESOLUTION ACCEPTING TRACTS OF LAND ADJOINING THE PRESENT CITY LIMITS ANNEXED TO THE CITY OF BROOKLAND, ARKANSAS, BY ORDER OF THE COUNTY COURT OF CRAIGHEAD COUNTY, ARKANSAS; AND ASSIGNING SAID ANNEXED TERRITORIES TO WARD 3.

WHEREAS, a petition was filed; pursuant to A.C.A. § 14-40-601, for the annexation of certain territory into the City of Brookland, Arkansas; and

WHEREAS, said petition for the annexation of these lands was duly signed 100% of the owners of real estate to be annexed; and

WHEREAS, the County Judge issued an Order after review of the petition and verifications for completeness and accuracy, and determined there were no enclaves created by the annexation, and confirmed that the petition contained a schedule of services; and

WHEREAS, the City of Brookland received this Order from the County Judge concerning these lands; and

WHEREAS, it is the desire of the City of Brookland Council of that said territory be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROOKLAND, ARKANSAS:

SECTION 1. That the described territory attached hereto and incorporated herein as if set forth word for word, contiguous to the City of Brookland, be and the same is hereby accepted as part of, and annexed to and made a part of the City of Brookland, Arkansas.

SECTION 2. That the following schedule of services shall be extended to the area by the City of Brookland, Arkansas within the statutorily required three (3) year period after the date the annexation becomes final, as follows:

- a. City Water Rate immediately.
- b. City Sanitation Rate immediately.
- c. Police protection immediately.
- d. Animal Control Immediately.
- e. Code Enforcement immediately.
- f. Street maintenance immediately.
- g. Mosquito Control immediately upon schedule



SECTION 3. That the above described territory shall be annexed to and made a part of Ward 3 of the City of Brookland, Arkansas, and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

SECTION 4. Notice. Within forty-five (45) days of the effective date of this ordinance the city clerk shall provide written notice, along with complete documentation, to the county clerk of each county in which the territory is affected.


