



In line with our conversation this morning, I am by this letter asking you to put on the agenda for the February 6th city council meeting my request that the land lying on the south side of Highway 319 leading to the Cadron Settlement Park, which I own through Faulkner Properties, Inc., be detached (de-annexed) from the city limits. No city services are provided to the property. have always planned to develop this property into a large lot subdivision. City water is not available to the property at an affordable cost, and as a result a building permit cannot be obtained to allow construction. I currently have a pending sale of a portion of this property contingent upon the property being removed from the city limits so that the buyers can commence construction of their proposed residence.

Attached as Exhibit A is the legal description of the property in question, consisting of 58.88 acres.



AN ORDINANCE AMENDING THE BOUNDARY FOR THE CITY OF CONWAY BY RELEASING CERTAIN PROPERTY DESCRIBED BELOW FROM THE CITY LIMITS, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

Containing 32.40 acres, more or less; and

Tract 2:

Part of the N1/2 NW1/4 of Section 6, Township 5 North, Range 14 West, in Faulkner County, Arkansas, described as beginning at the SE corner of the N1/2 NW1/4; thence north 89 degrees, 54 minutes 49 seconds west along the south line of the N1/2 NW1/4 877.3 feet; thence north 1129.97 feet to the south right of way of State Highway 319; thence north 83 degrees 56 degrees 35 seconds east along the right of way 106.52 feet; thence north 86 degrees 01 minutes 07 seconds east along the right of way 570.49 feet; thence north 83 degrees 52 minutes 19 seconds east along said right 203.46 feet to east line of the N1/2 NW1/4; thence leaving the right of way south 1203.86 feet to the point of beginning, containing 23.48 acres, more or less,

be removed from the City of Conway, Arkansas. The City Council resolves to request the County Court to exclude the territory from the city limits of the municipal corporation, and remit it back to the County.

Section 2. That any ordinances or parts of ordinances in effect at the time of the passage of this ordinance that are in conflict with this ordinance are repealed to the extent of the conflict.
