


WHEREAS, following proper publication of notice of a public meeting held on April 29, 1996 to discuss the proposed annexation; and there being no objections thereto, and,


WHEREAS, an Order approving said annexation was entered in the Little River County Court on or about May 1, 1996 in the aforementioned cause, and,

MINUTES OF PUBLIC HEARING

6. That situated on said property is the football field and grandstands of said school district and said school district would like to have the benefit of Foreman City Police protection of said area.

This court finds that all other allegations contained in the aforementioned Petition have been sustained by adequate proof herein and specifically this court finds that all requirements for signature pursuant to A.C.A. §14-40-601 have been complied with. Further, the limits of the territory to be annexed have been accurately described in the Petition, and that the map attached thereto is accurate and helpful in showing the annexed area.
