- 2. The Petitioners published notice as required for three consecutive weeks in newspaper of county-wide circulation in this county.
- 3. The Court set this matter for hearing on January 13, 2016, and that no persons appeared or made any objections otherwise to the Petitioner's Petition.
- 4. The Petitioners to this action are the only owners of the real property which is described on the attached Exhibit A. The real property described on the attached Exhibit A is entirely contiguous to the City of Greenwood, Arkansas.
- 5. The Court finds that it is in the best interest of the real property and also the best interest of the county and the City of Greenwood that this property be annexed into the City of Greenwood, Arkansas. The court finds that the limits of the territory have been

accurately described and that a map of the territory has been filed herewith. All real property owners within the territory have approved the Petition.

6. The Court finds that such property shall be and is annexed into the City of Greenwood, Arkansas, upon the Petitioner obtaining acceptance via ordinance from the City of Greenwood as set out in Arkansas Statute Annotated 14-40-601 et. al.
