ORDINANCE NO. 6169

AN ORDINANCE ANNEXING CERTAIN LANDS THAT ARE COMPLETELY SURROUNDED BY THE INCORPORATED LIMITS OF THE CITY OF HOT SPRINGS (LAKESIDE ENCLAVE); AND FOR OTHER PURPOSES.

WHEREAS, A.C.A. 14-40-501—14-40-503 provides that unincorporated islands of land that have been surrounded by the incorporated limits of a municipality may be annexed by that municipality.

WHEREAS, the City of Hot Springs desires to annex certain lands more completely described below; and

WHEREAS, all necessary urban services, such as fire and police protection, are to be extended to such area within the time prescribed by law; and that

WHEREAS, the area to be annexed complies with the standards for lands qualifying for annexation which are set forth in ACA 14-40-302 and ACA 14-40-501; and

WHEREAS, H.S.C. 16-2-32 (d) establishes the procedure for zones annexed; and that

WHEREAS, a public hearing was held on September 6, 2016, regarding this proposed annexation; and

WHEREAS, on August 15, 2016, a legal notice was published setting out the legal description of the territory proposed to be annexed, and all known property owners within the area were notified by certified mail of their right to appear at the public hearing.

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the City of Hot Springs, Arkansas, as follows:

SECTION 1. That the following described unincorporated area which is completely surrounded by the city limits of the City of Hot Springs is hereby annexed to the City of Hot Springs

HARDISTER, 4166 AS CONVEYED TO PATRICIA ANN AND JAMES V. HARDISTER, AND 4168 AS CONVEYED TO PATRICIA ANN AND JAMES V. HARDISTER; BEING A PART SOUTHWEST 1/4 OF SECTION 11 AND PART OF THE SOUTHEAST QUARTER, SECTION 11, BOTH IN TOWNSHIP 3 SOUTH, RANGE 19 WEST, GARLAND QUARTY,

ARKANSAS; BEING CONTIGUOUS WITH THE EXISTING CITY OF HOT SPRINGS CITY LIMITS; AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF LOT 3 OF LAKESIDE VALLEY AS FILED IN BOOK 13 AT PAGE 51 IN THE RECORDS OF GARLAND COUNTY, ARKANSAS; THENCE SOUTHERLY ALONG THE EAST LINE OF SAID SUBDIVISION, 204.61 FEET MORE OR LESS TO THE CENTERLINE OF LAKESIDE ROAD; THENCE EASTERLY ALONG CENTERLINE 1608 FEET MORE OR LESS; THENCE NORTH 25 FEET MORE OR LESS TO SOUTHEAST CORNER OF GARLAND COUNTY PID NUMBER 4168 AS CONVEYED TO PATRICIA ANN AND JAMES V. HARDISTER BY WARRANTY DEED FILED AS BOOK 3435 AT PAGE 626 IN THE RECORDS OF GARLAND COUNTY, ARKANSAS; THENCE WESTERLY CONTINUING ALONG SAID BARTLETT TRACT, 434.12 FEET MORE OR LESS; THENCE NORTHERLY CONTINUING ALONG SAID BARTLETT TRACT, 786.29 FEET MORE OR LESS TO THE NORTHEAST CORNER OF GARLAND COUNTY PID NUMBER 4164 AS CONVEYED TO THE WHELAN FAMILY TRUST BY WARRANTY DEED FILED AS BOOK 2613, PAGE 637 IN THE RECORDS OF GARLAND COUNTY, ARKANSAS, BEING AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 11; THENCE WESTERLY ALONG THE NORTH LINE OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 11, 528.7 FEET MORE OR LESS TO THE SOUTHEAST CORNER OF LOT 5 OF EASTGATE II PHASE III SUBDIVISION AS FILED IN THE RECORDS OF GARLAND COUNTY, ARKANSAS; THENCE WESTERLY ALONG THE SOUTH LINE OF SAID SUBDIVISION 781 FEET MORE OR LESS TO THE NORTHWEST CORNER OF GARLAND COUNTY PARCEL ID NUMBER 4161 AS CONVEYED TO THE OUACHITA GIRL SCOUT COUNCIL BY WARRANTY DEED FILED AS BOOK 553, PAGE 363 IN THE RECORDS OF GARLAND COUNTY, ARKANSAS BEING AT THE NORTHWEST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 11 AS DESCRIBED IN SAID DEED; THENCE SOUTHERLY ALONG THE WEST LINE OF SAID SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER 773 FEET MORE OR LESS TO A POINT ON THE NORTH LINE OF GARLAND COUNTY PARCEL ID NUMBER 4162 AS CONVEYED TO MATTHEW AND KRISTEN EVERHART BY WARRANTY DEED FILED AS BOOK 3415 AT PAGE 98; THENCE EASTERLY ALONG SAID TRACT, 159 FEET MORE OR LESS TO THE NORTHEAST CORNER OF SAID TRACT; THENCE SOUTHERLY ALONG THE EAST LINE OF SAID TRACT, 308.93 FEET MORE OR LESS TO THE POINT OF BEGINNING.

SECTION 2. Necessary urban services, such as police and fire protection, shall be extended to such area at the time prescribed by law.

SECTION 3. Pursuant to H.S.C. 16-2-32(d), islands annexed by ordinance shall be assigned a temporary zoning classification of Rural Residential (R-1) at the time the board of directors annexes the territory by ordinance.

SECTION 4. The Board of Directors request that the Planning Commission hold a public hearing and recommend a permanent zoning classification to the Board of Directors prior to December 31, 2017.

SECTION 5. Construction-related permit fee waivers for new single family homes on lands annexed by this Ordinance shall be effective for a period of 36 months, elapsing on September 20, 2019.

SECTION 6. Lakeside Enclave owners who do not at this time have a current survey or professionally prepared legal description required to assign a permanent zoning district shall have the option to pursue permanent zoning without Planning Commission application fee through December 31, 2019

SECTION 7. Lands within Lakeside Enclave shall be assigned to City of Hot Springs Board District Six (6).
