#### ORDINANCE NO. 286-16

# AN ORDINANCE APPROVING ANNEXATION OF CERTAIN CONTIGUOUS LANDS TO THE CITY LIMITS OF THE CITY OF LAKE CITY ARKANSAS

WHEREAS, it has come to the attention of the City Council that certain property owners have filed a request to annex their property to the city limits of Lake City;

WHEREAS, the annexation is consistent with the growth in population in the city and the annexation has been approved by the Craighead County Judge's office, the County Clerk and County Assessor's office:

WHEREAS, the annexation petition conforms with the requirements of A.C.A. 14-40-609 in all respects;

WHEREAS, the property to be annexed is described as follows:

ALL OF LOTS 1 AND 3 OF THE UNITED STATES GOVERNMENT SUPPLEMENTAL SURVEY OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 6 EAST, THAT IS SITUATED IN THE SOUTH HALF OF THE NORTHWEST QUARTER OF SAID SECTION 28 AND LYING EAST OF PURCELL SLOUGH, AND ALL THAT PART OF THE SOUTH HALF OF THE NORTHWEST QUARTER OF SECTION 28, TOWNSHIP 14 NORTH, RANGE 06 EAST, LYING EAST OF PURCELL SLOUGH, CRAIGHEAD COUNTY, ARKANSAS, CONTAINING APPROXIMATELY 57 ACRES.

WHEREAS, acceptance of the property proposed to be annexed is in the best interest of the City of Lake City and should be approved;

THEREFORE, BE IT ORDAINED: That the City of Lake City approves the proposed annexation of the above described property to the jurisdiction of the City and that the property shall be subject to all rules, regulations and laws as the present City Limits from and after the passage of this Ordinance.
