IL CATIFIED AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN JAN 2 0 2015 TERRITORY TO THE CITY OF MANSFIELD, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MANSFIELD, AND ASSIGNING SAME TO Arkansas Secretary of State WARDS.

> WHEREAS, a Petition was filed with the Court Clerk of Sebastian County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Mansfield, Arkansas; and,

> WHEREAS, on December 8, 2014, the County Court of Sebastian County, Arkansas, found that the Petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Mansfield, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Mansfield, Arkansas, subject to the acceptance of same by the City Court of said City at the proper time, as provided by law; and

> WHEREAS, the time fixed by law for appealing from said Order of Annexation made by the County Court has expired and no appeal or suit has been taken from said Order.

> NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Mansfield, Arkansas:

> SECTION 1: That the following described lands and territories contiguous and adjoining the City of Mansfield, Arkansas, be and the same are hereby accepted as part of and annexed to and made a part of the City of Mansfield, Arkansas.

**SECTION 2:** That the above-described territory shall be annexed to and made a part of Ward Three (3) of the City of Mansfield, Arkansas and the same shall henceforth be a part of said ward as fully as existing parts of said ward.

**SECTION 3:** It being necessary to preserve the City's public health, safety, and welfare, an emergency is hereby declared to exist and this Ordinance shall take effect and be in full force from and after its passage and approval.



NOW, on this 8th day of December, 2014, there is presented to this Court by the petitioners and/or agents of the petitioners, a Petition for Annexation of Certain Territory, hereinafter more particularly described, to the City of Mansfield, Sebastian County, Arkansas, and this Court, being fully advised of the facts and the law, does hereby find, adjudge and decree as follows:

This Court finds that the Petition referenced herein was filed more than thirty (30) days prior to this date.

This Court further finds that notice of the hearing on this matter was published one (1) time a week for three (3) consecutive weeks as required by A.C.A. § 14-40-602.

This Court finds that a majority of the total number of real estate owners in the area affected by this Petition have signed said Petition and that such majority owns more than onehalf of the acreage affected.

This Court further finds that the territory sought to be annexed was accurately described in said Petition and that said territory is contiguous to the boundaries of the City of Mansfield, Sebastian County, Arkansas.

This Court further finds that attached to and made a part of said Petition is an accurate map of the territory sought to be annexed to the City of Mansfield, Sebastian County, Arkansas.

This Court finally finds that the prayer of the Petition is right and proper.


