ORDINANCE 2004-09

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF MULBERRY, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF MULBERRY, ARKANSAS, AND ASSIGNING SAME TO WARDS AND ISSUING ZONING FOR SAID PROPERTY.

WHEREAS,

Petition was filed with the County Clerk of Crawford County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Mulberry, Arkansas; and

WHEREAS,

on October 11, 2004, the County Court of Crawford County, Arkansas, found that said territory was contiguous and adjoining the present corporate limits of the City of Mulberry, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said petition; that proper notice had been given, for the time and in the manner prescribed by law and that all things pertaining thereto had been done in the manner prescribed by law and that said lands and territory should be annexed to and made a part of the City of Mulberry, Arkansas, subject to the acceptance of the same by the City Council of said City at the proper time, as provided by law; and
