




Arkansas Code 14-40-101.

RESOLUTION

WHEREAS, D.F.M. Properties, Inc., owning lands adjacent to the City of Marshall, Arkansas, lately filed, by Russell L. Falls, its President, and Jimmie L. Falls, its Secretary, their proper Petition in the County Court of Searcy County, Arkansas, wherein, among other things and matters therein set forth, they prayed for orders of the Court annexing the territory described as follows to said City.

Part of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 36, Township 15 North, Range 16 West described as follows: Commencing at the Southeast corner of said SE $\frac{1}{4}$ NW $\frac{1}{4}$, thence West along the South line of said forty, 1320 feet; thence North along the West line of said forty, 798 feet; thence East 1320 feet; thence South along the East line of said forty 798 feet returning to the point of beginning, containing 24.18 acres, more or less.

WHEREAS, after publication of due Notice an Order was signed by the Honorable Paul Ray Lee, County Judge of Searcy County, Arkansas, on the 15th day of June, 1999, granting the prayer of said Petition, and annexing the territory described above to the City of Marshall, Arkansas; and,

ORDER OF ANNEXATION

On this a regular day of a regular term of the County Court of Searcy County, Arkansas, there is presented to the Court by John C. Aldworth, agent of the Petitioners, a Petition for annexation of certain territory, hereinafter more particularly described, to the City of Marshall, Arkansas, and the Court being fully advised of the facts and the law, doth hereby find, judge and decree as follows:


