SHARON STANDOOR STAND

AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN AND ACCEPTING THE ANNEXATION OF CERTAIN ACCEPTING THE CITY OF OZARK, ARKANSAS, AND MAKING SAME PART OF THE CITY OF OZARK, ASSIGNING SAME TO WARDS, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, a Petition was filed with the County Clerk of Franklin County, Arkansas by the only real estate owners of the hereinafter described territory praying that said territory be annexed to, and made part of the City of Ozark, Arkansas; and

WHEREAS, on the 28th day of February, 2007, the County Clerk of Franklin County, found that the Petition was signed by the only real estate owner in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Ozark, Arkansas; that an accurate plat or map of said territory had been filed with and made part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said land and territory should be annexed to and made part of the City of Ozark, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and

WHEREAS, the time affixed by law for appealing from said Order of Annexation made by the County Court has expired and no appeal has been taken from said Order.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS:

SECTION I: That the following described land and territory contiguous and adjoining the City of Ozark, Arkansas, be and the same is hereby, accepted as passed and is hereby annexed to and made part of the City of Ozark, to wit:

See attached legal description.

SECTION II: That the above described territory shall be annexed to and made a part of Ward 1 of the City of Ozark, and same shall henceforth be a part of said ward as fully existing of said ward.

<u>SECTION III:</u> This Ordinance being necessary for the preservation of public health, safety, and welfare, an emergency is therefore declared, and shall be in full force and effect immediately upon its passage.
