AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF OZARK, ARKANSAS, AND MAKING SAME A PART OF THE CITY OF OZARK, AND ASSIGNING SAME TO WARDS.

WHEREAS, Petition was filed with the County Clerk of Franklin County, Arkansas, by the majority of the real estate owners of the hereinafter described territory praying that said territory be annexed to, and made a part of the City of Ozark, Arkansas; and, WHEREAS, on the 16 day of November, 1995, the County Court of Franklin County, Arkansas, found that the Petition was signed by a majority of the real estate owners in said territory; that said territory was contiguous and adjoining the present corporate limits of the City of Ozark, Arkansas; that an accurate plat or map of said territory had been filed with and made a part of said Petition; that proper notice had been given for the time and in the manner prescribed by law, and that all things pertaining thereto had been done in the manner prescribed by law, and that said lands and territory should be annexed to and made a part of the City of Ozark, Arkansas, subject to the acceptance of same by the City Council of said City at the proper time, as provided by law; and WHEREAS, the time fixed by law for appealing from said Order of Annexation made by the County Court has expired and no appeal has been taken from said Order. NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS: That the following described lands and territory contiguous and SECTION 1: adjoining the City of Ozark, Arkansas, be and the same is hereby accepted as part of and annexed to and made a part of the City of Ozark. See attached That the above described territory shall be annexed to and SECTION 2: made a part of Ward _____ of the City of Ozark, and same shall henceforth be a part of said ward as fully as existing parts of said ward. Passed and approved this 8th day of January , 199.

DECREE OF ANNEXATION

On this regular day of a regular term of the County Court of Franklin County, Arkansas, there is presented to the court by Anderson Whitson Ford, Inc. and Holley, Inc., a Petition for Annexation of certain territory, hereinafter more particularly described, to the City of Ozark, Arkansas, and the Court being fully advised of the facts and the law, doth hereby find, judge and decree as follows:

The Court finds the Petition was filed more than thirty (30) days prior to this date and that in said Petition the said John Ross was selected by the Petitioners to act on their behalf in filing and presenting the Petition.

The Court doth find that a majority of the total number of real estate owners in the area affected by this Petition have signed said Petition and that such majority owns more than one-half of the acreage affected.

The Court further finds that the territory sought to be annexed was accurately described in said Petition and that said territory is contiguous to the boundaries of the City of Ozark, Arkansas.

The Court further finds that attached to and made a part of said Petition is an accurate map of the territory sought to be annexed to the City of Ozark, Arkansas.

The Court further finds that the prayer of the Petition is right and proper.

Therefore, the Court doth hereby ORDER, JUDGE and DECREE that the following described territory be and the same is hereby annexed to and made a part of the

City of Ozark, Arkansas, to-wit:

TRACT NO. 1: Part of the West Quarter of the Northwest Quarter of Section 26 AND part of the East half of the Northeast Quarter of Section 27, All in Township 10 North, Range 27 West, more particularly described as beginning at a point 128.51 feet East and North 01 degrees 24 minutes East 1295.56 feet, from the Southwest Corner of the Southwest Quarter of the Northwest Quarter of Section 26, running from said point of beginning the following courses and distances:

North 60 degrees 14 minutes East 270.4 feet, thence North 48 degrees 49 minutes West 179.1 feet, thence North 52 degrees 52 minutes West 455.6 feet, thence South 04 degrees 01 minutes West 697.3 feet, thence North 61 degrees 38 minutes East 354.85 feet to the Point of Beginning, and containing 4.29 acres, more or less.

TRACT NO. 2: Part of the West Quarter of the Northwest Quarter of Section 26 AND part of the East half of the Northeast Quarter of Section 27, All in Township 10 North, Range 27 West, more particularly described as beginning at a point 725.06 feet North and 128.51 feet East of the Southwest Corner of the Southwest Quarter of the Northwest Quarter of Section 26, and running the following courses and distances:

North 01 degrees 24 minutes East 572.5 feet, thence
South 61 degrees 38 minutes West 354.85 feet, thence
South 04 degrees 01 minutes West 458.0 feet, thence
South 89 degrees 38 minutes East 127.1 feet, thence
North 67 degrees 05 minutes East 138.3 feet, thence
South 89 degrees 44 minutes East 76.1 feet to the Point of Beginning and
containing 3.77 acres, more or less, AND CONTAINING IN THE

Part of the Southwest Quarter of the Northwest Quarter (SW 1/4 NW 1/4) of Section 26, Township 10 North, Range 27 West, described as commencing at the Southwest corner of the said SW 1/4 NW 1/4, thence North 725.06 feet, thence East 128.51 feet to the Point of Beginning, thence continue East 209.42 feet, thence North 208 feet, thence East 208 feet to the West right of way line of Arkansas Highway No. 23, thence North along said right of way a distance of 105.07 feet, thence West 417.42 feet, thence South 313.07 feet to the Point of Beginning, containing 2 acres, more or less.

The Court doth further order that the original papers in this cause be delivered to the Clerk of Franklin County, Arkansas, same to be properly recorded upon the records of Franklin County, Arkansas, and the Clerk, after properly recording and filing the original papers, prepare transcripts of same; that one of the certified transcripts be delivered to the City of Ozark, Arkansas, one copy to the Secretary of State and one copy to the Director of the Tax Division of the Arkansas Public Service Commission.


