AN ORDINANCE CONFIRMING THE ANNEXATION OF THE FOLLOWING DESCRIBED LANDS: Single So

Tract No. 1:

All Lands lying within the perimeters of a boundary described as follows:

Beginning at a point at the northeast corner of Section 1, Township 16 North, Range 1 East, thence go southerly along the east section line of Section 1 and Section 12 to the southeast corner of Section 12, thence go westerly along the section line between Section 12 and Section 13, Section 11 and Section 14, and Section 10 and Section 15 to the southwest corner of the East Half of the Southwest Quarter of Section 10, which is the Hoxie City Limit, thence go northerly along the west line of said East half, Southwest Quarter, Section 10 (Hoxie City Limit Line) to the northwest corner of said East Half, Southwest Quarter, Section 10, thence go easterly along the North line of said East Half, Southwest Quarter, Section 10 (Hoxie City Limit Line) to the center of said Section 10, thence go northerly along the quarter section line between the Northeast Quarter and Northwest Quarter of said Section 10 (Hoxie City Limit Line) to the northwest corner of said Northeast Quarter, Section 10 (Hoxie City Limit Line), thence go easterly along the north section line of said Section 10 to the northeast corner of Section 10, thence go northerly along the west line of section 2, to the Northwest corner of said Section 2 (which is Walnut Ridge City Limit line), thence go easterly along the north section of said Section 2 and Section 1 to the northeast corner of said Section 1, which is the point of beginning, all being in Township 16 North, Range 1 East, Lawrence County, Arkansas. Beginning at a point at the northeast corner of Section 1, Township 16 North, Range 1 East, thence go southerly along the east section line of Section 1 and Section 12 to the southeast corner of Section 12, thence go westerly along the section line between Section 12 and Section 13, Section 11 and Section 14, and Section 10 and Section 15 to the southwest corner of the East Half of the Southwest Quarter of Section 10, which is the Hoxie City Limit, thence go northerly along the west line of said East half, Southwest Quarter, Section 10 (Hoxie City Limit Line) to the northwest corner of said East Half, Southwest Quarter, Section 10, thence go easterly along the North line of said East Half, Southwest Quarter, Section 10 (Hoxie City Limit Line) to the center of said Section 10, thence go northerly along the quarter section line between the Northeast Quarter and Northwest Quarter of said Section 10 (Hoxie City Limit Line) to the northwest corner of said Northeast Quarter, Section 10 (Hoxie City Limit Line), thence go easterly along the north section line of said Section 10 to the northeast corner of Section 10, thence go northerly along the west line of section 2, to the Northwest corner of said Section 2 (which is Walnut Ridge City Limit line), thence go easterly along the north section of said Section 2 and Section 1 to the northeast comer of said Section 1, which is the point of beginning, all being in Township 16 North, Range 1 East, Lawrence County, Arkansas. Also described as all of Section One (1); all of Section Two (2); the East half of the Southwest Quarter (E 1/2 SW 1/4) and the East Half (E 1/2) of Section Ten (10); all of Section Eleven (11) and all of Section Twelve (12), all said lands lying in Township Sixteen (16) North, Range One (1) East in Lawrence County, Arkansas.


BEGINNING AT THE EXTREME SOUTHWEST CORNER OF THE EXISTING CITY LIMIT WHICH POINT IS THE INTERSECTION OF THE NORTH RIGHT-OF-WAY OF JAY STREET AND THE NORTH-SOUTH 1/4 SECTION LINE OF SECTION 33, T-17-N, R-1-E, THENCE NORTHERLY ALONG SAID NORTH-SOUTH 1/4 SECTION LINE TO THE NORTH LINE OF SAID SECTION 33, THENCE EASTERLY ALONG SAID NOTRH SECTION LINE TO THE SOUTHWEST CORNER OF SECTION 27, THEN GO NORTHERLY ALONG THE WEST LINES OF SECTION 27, SECTION 22 TO THE NORTHWEST CORNER SECTION 22, THEN GO EASTERLY ALONG THE NORTH LINE OF SECTION 22 TO THE NORTHEAST CORNER OF SECTION 22 THEN GO NORTHERLY ALONG WEST SECTION LINE OF SECTION 14 TO THE NORTHWEST CORNER OF SECTION 14, THEN GO EASTERLY ALONG THE NORTH SECTION LINES OF SAID SECTION 14 AND SECTION 13 TO THE NORTHEAST CORNER OF SECTION 13, THEN GO SOUTHERLY ALONG THE EAST SECTION LINES OF SECTION 13, SECTION 24, SECTION 25, AND SECTION 36 TO THE SOUTHEAST CORNER SECTION 36, ALL BEING LOCATED IN T-17-N, R-1-E, THEN GO WESTERLY ALONG THE SOUTH SECTION LINE OF SECTION 36 AND SECTION 35 TO THE INTERSECTION OF THE NORTH RIGHT-OF-WAY LINE OR ARK HWY 91 TO THE EXISTING SOUTHEAST CITY LIMIT LINE OF THE CITY OF WALNUT RIDGE, WHICH IS THE END OF THE NEW CITY LIMIT BOUNDARY LINE.


