ORDINANCE NO. 650-01

AN ORDINANCE DETACHING PARTS OF SECTION ONE (1), TWELVE (12), AND THIRTEEN (13), TOWNSHIP SIXTEEN (16) NORTH, RANGE ONE (1) EAST FROM THE CITY LIMITS OF WALNUT RIDGE, ARKANSAS.

BE IT ORDAINED BY THE WALNUT RIDGE CITY COUNCIL AS FOLLOWS:

Section 1. That all landowners located in Section One (1); and all of Section Twelve (12) North and East of the railroad; and Section Thirteen (13) North and East of the railroad, all in Township Sixteen (16) North, Range One (1) East, Lawrence County, Arkansas, have filed a proper affidavit and petition requesting that their properties in Sections One (1), Twelve (12) and Thirteen (13), Township Sixteen (16) North, Range One (1) East which have recently been annexed to the City of Walnut Ridge, Arkansas be detached.

Section 2. That a plat of the area reflecting the land which is to be detached is attached to this ordinance and incorporated herein and made a part hereof.

Section 3. The City Council of Walnut Ridge does hereby approve the request of all landowners described in Section 1 hereof and does hereby order that their property described in Section 1 hereof be detached from the City of Walnut Ridge, Arkansas and henceforth said property is no longer a part of the City of Walnut Ridge, Arkansas.

Page Two

Section 4. The City Clerk is hereby order to certify a copy of this ordinance and the plat along with a copy of the qualifying affidavit to the County Clerk who is hereby requested to forward the documents to the Secretary of the State of Arkansas. The County Clerk is also requested to forward one copy of the plat and one copy of this ordinance to the director of the tax division of the Arkansas Public Service Commission.

Section 5. These proceedings have been conducted and approved pursuant to Ark. Code Ann. 14-40-608.

Section 6. This Ordinance being necessary for the public health, safety and well-being of the citizens of the Town of Walnut Ridge, Arkansas, an emergency is hereby declared and this Ordinance shall take effect immediately upon passage hereof.





AN ORDINANCE CONFIRMING THE ANNEXATION OF THE FOLLOWING DESCRIBED LANDS:

Tract No. 1:

All Lands lying within the perimeters of a boundary described as follows:




